

SECTION A: APPLICATION DETAILS

A1. WHAT IS THE APPLICATION PERIOD FOR AIA KIDS 360 PROTECT CAMPAIGN?

The application period is from 4 October 2023 to 30 June 2024, or upon 30,000 policies issued, whichever is earlier.

A2. WHO CAN APPLY FOR AIA KIDS 360 PROTECT CAMPAIGN?

- Insured parent/legal guardian and child must be Singapore Resident[^] and hold a valid Birth Cert/NRIC/ FIN.
- Insured parent/legal guardian must be within the age limit of 18 to 65 years old (age last birthday).
- Insured child must be within the age limit of 2 weeks old to 17 years old (age last birthday).
- Insured parent/legal guardian and child must not be a citizen of a sanctioned country or a Prohibited Person.
- Insured parent/legal guardian must provide his/her Marketing Consent (defined in the Campaign Terms and Conditions) to AIA.

A3. ARE BOTH PARENTS REQUIRED TO APPLY FOR AIA KIDS 360 PROTECT CAMPAIGN?

The applicant can be either parent (Father or Mother) or the legal guardian.

A4. CAN I APPLY FOR MY CHILDREN?

Yes, you can. It is compulsory for either parent or legal guardian to sign up as the main applicant and add your child(ren) between 2 weeks old and 17 years old (age last birthday) into the same application.

B2. WHEN DOES AIA KIDS 360 PROTECT COVERAGE START AND END?
